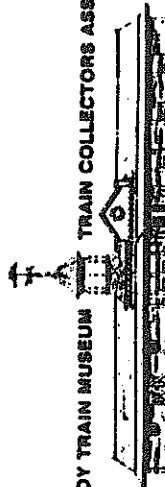
I would suggest that you include all the National Officers in your mailing if you feel the need to improve the communication between your members and the National.

Dear Joe,

I received the Metca Newsletter for September this morning and read with interest your Metca Soapbox request. I am replying solely as Editor of the T.C.A. Quarterly and in no other capacity. The guidelines for the Quarterly as postulated in the T.C.A. Board Policy Book is as follows:

The T.C.A. Quarterly is for the purpose of publishing material of an historical tinplate nature, the operation of/and collecting of tinplate, stories about collectors and their collections, and material of like nature.

When I became Editor in the Spring of 1979, I instituted a column called the Drumhead and at that time laid the ground rules for this column in my Editor's column from which I quote, "We ask only that this column be kept to 'train talk' exclusively, keeping politics and personalities for the 'Tuesday Night Hot Stove League.' I have been delighted with members responses to this column, and the Drumhead in the October Quarterly will be three pages.

I do feel that T.C.A.'s strength comes from a strong, forceful, and dedicated leadership. At present, in my opinion, any member who has 'new suggestions or complaints' can obtain an audience beginning with his or her division president and work up the ladder.

One thing that members seem to appreciate most about our organization is the lack of controversial and worldly discussions either in our publications or at our meets. . . this is a hobby and an escape from the soapboxes of the times.
