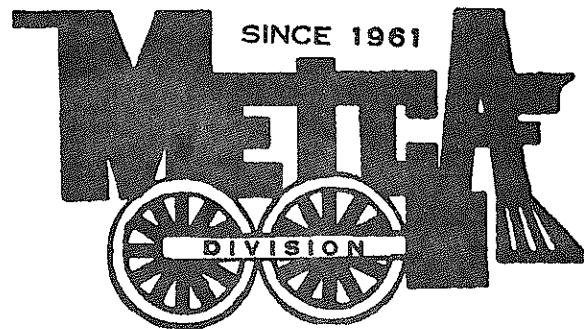

## MINUTES OF METCA DIVISION BOARD OF DIRECTORS MEETING

ON SUNDAY, MAY 7, 1995  
HUNGARIAN CLUB HALL, WOODBRIDGE, NJ

### OLD BUSINESS:

1. Motion to approve minutes of November 6, 1994 meeting by Charles Feyh and seconded by Lee Minster.
2. President's report of raffle ticket sales on the 1991 convention car raffle is 104 tickets sold for a total of \$312.00 to date.
3. With the appointment by the President of our newest director Chris Uchrin, we are in better shape than before but will still need at least 1 more director.
4. At this time we have several members who are willing to help out at our divisional shows with questions in regards to information about standards & frauds of various train related items. However none of these people want to get involved in any way with the National Standards Committee.

### NEW BUSINESS:

1. Board again unanimously approved the continuing of the 1/8 page ads and calendar of meets listings in the National Headquarters News.
2. President explained the three agenda items submitted for the 1995 BOD Meeting in June in Seattle, and also polled the board to see if anyone was going to Seattle and could serve as a possible alternate, as no one else was going I would report no alternate to the National Secretary.

3. President informed the board of the 1994 York Convention Banquet Cars that we had received at the April 1995 York Meet, and discussed the raffling off of these cars in the same basic way as our 1991 Car raffle and also the selling of these cars at our upcoming shows. Based on the auction prices of these cars at the York Convention we decided to make the selling price of these cars \$ 375.00. Also the raffling of cars would probably be best at \$ 3.00 per ticket with about 250 tickets total. Final amounts to be finalized on or before our September 10, 1995 show.

4. Board discussed and approved our 1996 show dates to be: Hungarian Hall on May 5, 1996  
Garfield Boys Club on September 8 and November 3, 1996  
These dates are tentative until confirmed by the 2 Hall renters.
5. Board approved the continuation of the 1/8 page ads and listings in the National headquarters News.

6. Sect/Trea Marlene Minster gave summary of show results as:  
A total of 50 8 foot tables of dealers and about 8 more used for our operating "O" layout and the TV/VCR set up that ran the new Standards Committee Video (we sold 6 tapes as a result of this presentation). No tables were needed for the Standard Gauge Layout and Test Track as they were located on the elevated stage. Also we had 160 paid member admissions which doesn't include the wives and children. Dues paid at the door for 1995 were 27 plus 1 booster. Dues paying members to date are 175. With today's revenue after expenses being paid we have about \$ 3400.00 in the treasury.

Taking together all expenses incurred to hold our May 7 show and then adding up our table sales and admissions we were happy to see that we came out ahead so show was self supporting. This was very good news to all as this was our third show in a row that did not lose any money.
