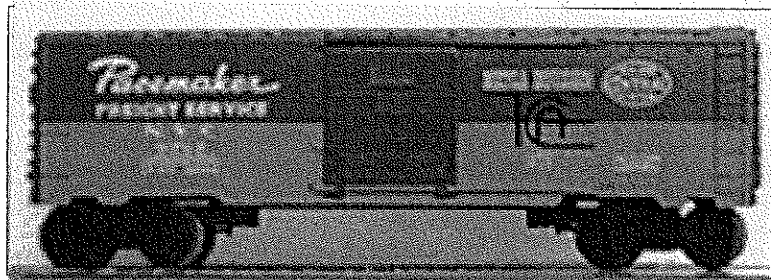

Draft Minutes of the Metropolitan Division Board of Director's Meeting

Sunday, September 17, 2006 at the Parsippany P.A.L. Building, Parsippany, NJ

(To be adopted on November 12, 2006)

Meeting opened by John Clinton, President at 2:35PM

Board Members Present:

John Clinton, Pres.; John Bernich, V. Pres.; Bill Brennan, Dir.; Bob Dobrowolski, Dir.; Rem Hunnewell, Dir.; Scot Kienzlen, Dir.; John Lomio, Dir.; Kevin Quinn, Dir.; Pat Scuorzo, Dir.; Steve Siniawa, Dir.; Chris Uchrin, Dir. Absent: Paul Dinatale, Treas.

Treasurer's Report:

Postponed until Paul returns.

Unfinished Business:

1. Motion to amend the minutes of March 26, 2006 meeting by Rem to include that we discussed changing the format/layout style of the show mailings. 2nd, by Bob; all voting yes except abstention by Chris who was not at the meeting. Motion to accept amended minutes by John Bernich, 2nd by Rem, all voted yes.
2. John Bernich reported that he and Steve were still getting prices for METCA hats as a fund raiser item.
3. Steve reported that the man with the free HO layout was in Florida and would contact him when he returns to NJ.
4. Steve has the following on the 2007 tentative dates we picked out for the PAL; Dates available are: March 18th, September 16th and November 11th. Also the hall rental has gone up starting July 1, 2006. The city of Parsippany is now supervising the operations of the PAL due to operating losses in the past. We were paying \$1050.00 per show since 2002-5 years. New cost is \$1260.00.
5. Scot reports he is still researching the list of Free Ads.
- 6 A. Scot reports that he and Mike Rapp are continuing looking into locations in Yonkers, NY. Long Island and Manhattan.
B. John Clinton reports that halls he has looked into are: Woodbridge Elks \$650.00 but we have to rent table sat \$9.00 each; Hungarian-American Hall \$1400.00; Holiday Inn Carteret \$650.00 but 2nd floor location; and the Ramada Inn \$5,000.00.
C. Rem reports following: Garfield Boys Club \$400.00 including tables and setup; schools in Oakhurst area %575.00 per school ass't small locations.
- 7 A. Motion to form 3-man committee to explore new locations and give board recommendations (committee cannot enter into contracts for hall rentals or reserve dates with halls) by Kevin and 2nd by Chris. All voted yes.
B. John Clinton appointed following to committee: Scot, Rem and Kevin. Committee to give preliminary findings at Nov. show and possibly have new locations for 2007 to discuss.
8. Rem made motion, 2nd by Kevin to appoint Scot Editor of Newsletter/Mailing for the purpose as discussed in March to reformat the design of the newsletter. Scot to receive from John his President's letter, Paul will provide the Treasurer's report and Steve will send the rest of the pages of the mailing. Scot will take all info and arrange it into his new design and send John the finished mailing sample for final approval before Steve prints and mails it. This arrangement can be done away with if it turns out not to work out. All voted yes.

New Business:

1. The Treasurer's report is postponed until Paul returns.
2. John Clinton reports he is looking into having hobby shops giving METCA gift Certificates as Door Prizes.
3. John Clinton reports discussed possibility of a METCA display in with a New York Location Museum. A Ms. Hoffman from NY has gotten a grant for a Museum type Building and would have a section that may be perfect for a train display and if it works out would give METCA exclusive rights to a display there. Location is still to be finalized, maybe in Brooklyn.
4. John Clinton also talked with Lionel Ceo Jerry Calabrese about METCA's upcoming 45th Anniversary in November. John will follow up with a letter to him and maybe they can do something for us.
5. Motion to increase division dues to \$10.00 per year with stipulation that Board will designate one show per year as a Free Admission for METCA memebtrs who are Up-to-date dues payers, by Scot and 2nd by Bob. All voted yes.
6. Rem reported he received from Natonal TCA a list of 991 METCA members/applicants E-MAIL ADDRESSES, cost from National was \$29.82, cost donated by Rem. Rem Sent out letter to the 991 about 40-50 bounced back as no good for whatever reasons. He did get back response from George Wybenga of Caboose Art who sent a framed engine sample fof his work. Art prints sell for \$45-55 each. Rem will look into other pictures to possibly sell for profit at our shows.
7. Rem discussed for thought only the forming of a Chapter in Monmouth County as he knows 7 people who are interested in it.
8. John Clinton was given a calendar from another division that we can use fora floor raffle prize in November.
9. Rem discussed how National puts Headquarter News on its web page and made motion to put METCA newsletter on our web page, 2nd by John Bernich. All voted yes.
10. John Clinton asked about October York Advertisement about a METCA Standard Gauge Moduular Layout and was told by Scot that it was a printing error as Eastern thought it was METCA because a few up front members belonged to us.
11. Motion that the current President of Division send out a first contact postcard/letter to the 1st mailing applicants under METCA in the National Headquarters News and a later follow up phone call by him or his designated alternate. Motion by Scot and 2nd by Rem. All voted yes.

Motion to adjourn at 5:30 PM by Chris Uchrin and seconded by Rem. Meeting adjourned by John Clinton.
