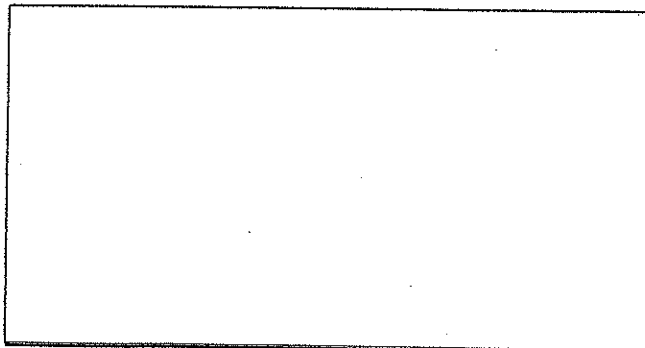

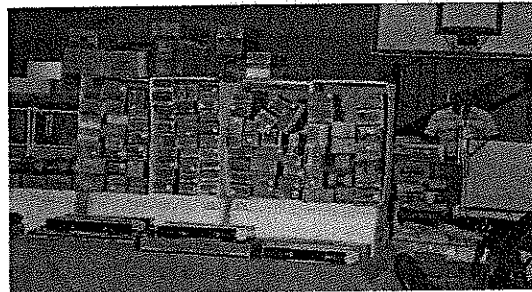

While at the Meet'n'Greet, I approached Scot and discussed having a train show in Brooklyn. By the time we parted company, the groundwork was laid and the result is our upcoming show on November 3. This will be the first ever TCA show in Brooklyn.

## **Routine Lubrication Tips**

To keep your railroad empire rolling smoothly, it is important to maintain a regular lubrication schedule for your motive power. With a little preventative maintenance, you can easily avoid some of the common problems of poor operation and engine failure. Always refer to the original manufacturers instructions for specific instructions. A few drops of oil should be applied to the roller pickups after every 20 or so hours of operation. On steamers, also apply oil to the crossheads and side rod screws. Don't forget to apply a drop or two to the coupler knuckle pin about every six months as well. Gearboxes should be packed with grease about every 50 or 60 hours of operation if needed. I use Lithium grease for this. Also while the engine is on your bench, lightly apply grease to any exposed gears. Remember, a little pre-planned maintenance on your part will keep your engines running smoothly.

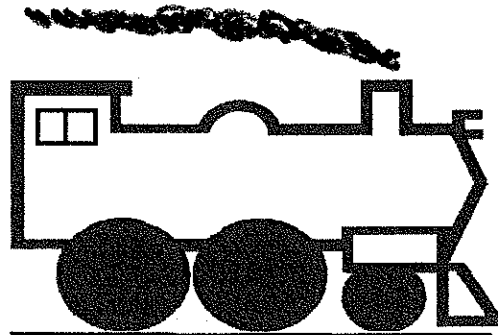
