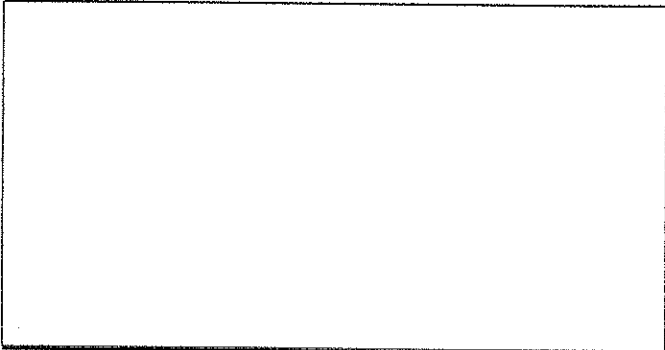

We received 115 Ballots from the 191 mailed to the membership. This equates to a 60% return rate!

Three ballots were not counted.

1. Ballot from an associate member not eligible to vote
2. Ballot from person not on the official list
3. Ballot whose TCA # did not match the name of the person

These ballots, no matter how they voted, would not change the results.

The three people on the election committee counted the ballots at the Duncan Donuts, Cranford NJ. One person read the ballots, one person recorded the ballots, and one person cross-checked the name and TCA # with the list provided by Rem Hunnewell. This list contained the METCA members eligible to vote. All counts were done a minimum of two times to ensure accuracy.

The process lasted from Noon until 2:00PM.

The only recommendation for future Elections is that a return address label is put on the envelope used to mail back to the EC Chair. We had a hard time figuring out the names of around 40 ballots and this took time to look them up via TCA Number.

The hard copy tabulations with signatures will be forwarded to the Secretary for preservation.

The Election Committee achieved the goals set forth by the mission statement. We stand by the results and guarantee the integrity of the process.

We also want to thank the members of METCA who have helped in the revitalization of this fine organization. There are a number of events / announcements coming up that will make you glad you're a part of METCA.
