National Convention Report – 2008

Late last June, I had the opportunity to travel to my first-ever TCA National Convention... a real eye-opener! I have lots of good, fun things to talk about; the drives up and back (scenic and relaxing), the hotel (welcoming and comfortable), the NETCA Division hospitality (complete with New England charm), the last-minute dinner cruise ticket (I got SO lucky!), my dinner partner (a great story), the new friendships (some great new ideas!), the fire alarm during our Executive session (whups), the welcome party (SO much food!), and of course, the trains and display layouts (eye candy~ and inspiring)!

I went primarily to the NETCA-sponsored Convention to attend the two-day National TCA Board of Director's meeting; personal obligations and commitments constrained me from attending the full duration. The BOD's agenda was 49 pages long, with no less than 26 motions to be introduced, seconded, discussed and voted upon. You will be pleased to know that our METCA Division motion~ wherein we will be able to display other train show flyers~ was passed unanimously. Your National BOD set a record in getting all those motions recognized and handled~ and excellent example of teamwork!

As a business trip, this one was fun! Some of that business was listening to the exciting plans for the 2009 National Convention in Scottsdale, AZ... and what a show the Desert Division has in store for all TCA members! Watch for updates in the TCA's National Headquarters Newsletter~ and take a **good** look at the convention cars they're offering~ lots of fun! Part of that business (the hard part) was dealing with budget concerns; and the part of that business that will immediately impact METCA members was a vote to bring the question of a dues increase to the national membership.

By a vote of almost 2-1, it was decided, on the upcoming national election ballot, that the national membership will be asked to approve a \$3.00 per year increase. I was one of those in the majority. The request comes at a time when TCA is dealing with distressing financial news and substantial drains on its resources, not the least of which is declining enrollment. Despite efforts of recruiting new TCA members, our net loss of membership is over 1,000 for this year. Couple that with the realization that approximately 1/3 of the current membership will be eligible for HR membership (in which there is no dues payment but mailings continue normally), well, you can begin to see the financial difficulties about to envelop the TCA.

I made the proposals that the "Life Membership" category be revisited (even only 200 members at \$800 is significant); that the parameters for "Honor Roll Membership" be altered and tightened (even if 200 members are disqualified for a few years, the dues is significant); and that provisions for a donation to the National Endowment Fund be made on the annual National Membership renewal forms (imagine if each member included just a \$1.00 donation).

These will all be reviewed. While each by itself will not solve the financial bind, together they can put a significant dent in the very substantial financial hole in which the TCA finds itself.

But, the convention was not ALL about business. There were TRAINS to be had! I scored my share, too~ including a nice 2332 original GG-1 and a great little operating 675 Lionel steamer~ watch for its appearance on our interactive display layout. I also had the opportunity to attend the Wednesday evening dinner cruise on Lake Champlain. Spectacular scenery, excellent food and wonderful conversations.

I came away from the TCA National Convention renewed and invigorated; and looking forward to my trip to Arizona in 2009. As **your** representative to the TCA's National Board of Directors, please don't hesitate to contact me, or stop by at any of our METCA shows to speak with me personally. I am always available to focus on your comments, questions and concerns.

Service Hints



How to check armatures –

1st check - Take 2 leads from a transformer using 18-20 volts. Touch one lead to the axle of the armature. With the other lead touch each segment plate one a time. If there **IS NO** spark, the armature is ok.

2nd check – Touch one lead to a armature segment. Take the 2nd lead and touch it to the remaining armature segments. If there **IS** a spark, the armature is ok.

Long Island Sounds

You may recall that the Meet-n-Greet at Central Operating Lines in May produced among other things a suggestion that train clubs on LI join forces to obtain layout space on government property. Due to restrictions in TCA by-laws: METCA assumed a wait and see attitude.

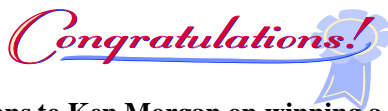
A second suggestion didn't gain too much ground. That suggestion was to have clubs participate in modular layouts. Modular layouts can be modest or become very large as participants join. Each participant builds one or more 30" by 48" module(s). The basic criteria is that the module have three tracks all spaced at precise locations measured from the front of the module. In this way each module can be connected with other modules. There are other construction standards as well as electrical standards. The choice of scenery and or buildings are the choice of the builder. A builder can also incorporate sidings, as long as the integrity of the 3 main lines are preserved. Many builders produce multiple modules and create a particular theme within their domain.

At METCA's latest Meet-n-Greet on the other side of the river, a new member, Bill Osburn, expressed an interest in modular layouts. METCA President, Scot Kienzlen told Bill to run with it. Your Waybill editor and myself have agreed to pool our efforts and build some modules. I can't promise how many modules will be built in time for the METCA show in Howard Beach, on November 15, 2008; but I promise that at least one will be on display to show you what is involved. In the mean time if you want more information on module building; please visit the following websites for information on the modular standards that METCA members will be using in their modular building efforts.

Collectors Corner

When METCA first considered issuing our Lionel 52485 New York Central Pacemaker Mint Car, our one and only goal was to have this car function as a fundraiser for the Division. Well, the Pacemaker Mint Car has done that and MORE. The car has become a collectible almost overnight. Let's talk a little about the history of the car.

In an innovative marketing maneuver, the METCA Board of Directors decided to set a firm quantity of cars that would be available to TCA members, even before the car was announced. Some saw this as a risky move (what if the cars don't sell); some saw this as a conservative move (demand will surely be greater than the supply).

Regardless, to have this car available in a timely manner (no year or year-and-a-half wait time here), this was a reasonable decision. At the end of 2007, our one and only ad was submitted to the National Headquarters News (NHN), our order was placed with Lionel, the car was announced in the Waybill to METCA members (Dec. 2007), and the ad appeared in the NHN for all TCA members to see (Jan. 2008).

The car was sold out by the beginning of February 2008, only 5 weeks after the ad appeared in the NHN. That's lightning fast. Orders continued to trickle in and they were put on a waiting list in case of a small production overrun. The cars arrived in NJ in August 2008 (2 full pallet loads of them) and our job of getting the cars into the hands of our members began almost immediately.

If there was any doubt (which there wasn't), once on the secondary market, it became crystal clear that the 2008 METCA New York Central Pacemaker Mint Car had become a collectible. Remember, dues paying METCA members like you were given the first opportunity at ordering this car. It's one of the perks of paying your dues and one of the ways that METCA says "Thank You".

I also agree that all items sold by me to any TCA member or at any TCA sponsored meet shall be sold on the basis that I represent all such items are authentic and in the manufacturer's original condition unless I have caused item to be appropriately marked as a restoration or reproduction.

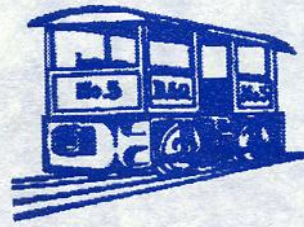
